
With this election the Coalition welcomes new members Peter DiSclafani, Glen Faulkner, Ritchie Gabriel, Jeff Gearhart and Mary Ann Van Benschoten. We say goodbye to members Drew Bogess, Bennett Ratcliff and Christine Viafore and thank them for their service to the watershed communities by serving on the Coalition's Executive Committee.

It should be noted that Peter DiSclafani, Supervisor of Shandaken was elected as a write-in candidate for Ulster County. Shandaken's membership in the Coalition has been suspended for failure to pay dues and thus it's elected officials are ineligible to serve on the Executive Committee. However, other than Mary Ann Van Benschoten from Marbletown, who was duly elected, there were no other candidates for the Ulster County seat. Therefore, until Shandaken makes up for its arrears, Mr. DiSclafani will not be able to vote on Coalition matters. He is however welcome to attend all Executive Committee meetings.

The next meeting of the Coalition will be on June 17, 2024 at 6:15 PM at the offices of the Catskill Watershed Corporation, 669 County Highway 38, Arkville, NY. At that meeting the new members will be seated. Then election for the Coalition's officers (Chair, Vice-chair and Treasurer) will be held either then or at the July meeting.

We look forward to continuing representing the interests of the Coalition on watershed issues to assure that our communities' voices are heard.
